#### Matters arising

**Rats** are proliferating near the ponds. Ken Worpole suggested that since people often got angry when asked not to feed bread to the ducks, could leaflets in English and Turkish be available to explain that feeding bread to the ducks encourages rats.

AP: Mark to ask Quentin Geurs for improved signage and for multi-language leaflets.  
Daphne noted this as an ongoing issue.

#### Park Manager's Report (delivered by Mark Forsyth)

**Café:** The tender process for the café is complete and results are to be announced shortly. The current operators, Company of Cooks did not apply. Their tenure ends 2nd November and will not be extended. If a new operator is not in place, provision will be made for temporary café facilities.

**Clissold House** was a finalist in the Hire Space Awards

**Butterfly dome:** CPUG have taken over running the butterfly dome and aims to stock it with native species. Mark and some volunteers are watering the plants regularly and some volunteer (planting and composting) days are being planned. Mark

has a list of 25 potential volunteers and encourages new volunteers to sign up.

**Clissold Park consultation:** One of the park's regular user surveys will be available shortly, online and with paper copies in the Café.

Clissold House will once again be participating in **Open House London** with regular historical tours led by Ken Worpole, Bea Pemberton and Mark Forsyth. Amir Dotan will be giving a talk on the history of the park

**Antisocial behaviour:** There are concerns of ongoing muggings in and around the park. Some shops and businesses on Church Street have been designated as safe spaces where children and young people can go for help if necessary. Clissold House is also included. Please inform police if you see anything of concern and contact the Park Manager or the Rangers who can quickly inform the police. You can do this anonymously. The police, Safer Neighbourhood teams, park management and schools are working together on this. Lorraine suggests getting a reference number when reporting to police.

**New River:** New pumps have been bought and will be installed soon. The bridge will be closed during installation.

**Popular Park Ranger, Erni** is currently working in Haggerston. Rangers and gardeners are employed Borough-wide. MF thanked Ernie for his dedicated work in Clissold Park and said our loss is their gain.
