3. Chairs Annual Report

Over the last 12 months, Clissold Park has continued to serve as a vital, much loved green space for the local community. CPUG have met regularly throughout the year, and meetings have been well attended and constructive. The User Group has remained an active voice for park users and has continued to liaise closely with Hackney Council on matters such as maintenance, budgets, accessibility, and anti-social behaviour.

CPUG has welcomed new members, reps and volunteers, and had a busy year hosting monthly litter picks, bat walks, bird surveys and ecology sessions, which have helped strengthen community ties and been a huge benefit to the park, along with all that live in and use it. We have created new habitat by installing bird boxes, planting and assisting with dead hedge construction. We've also updated our website, promoted our merchandise, raised funds, improved our email updates and grown our social media following, ensuring timely updates and encouraging two-way dialogue with the public.

The past year has seen several positive developments in Clissold with the new toilet facilities opening, the café contract being awarded, the playground renovation plans getting started and more.

ORDINARY MEETING

Park Keeper's Report

Cafe update

Works are coming along well and Finks are making good progress. They are eager to open the Rose Garden kiosk as soon as they can and will be announcing dates shortly. I will be sure to share this update as soon as I have received it.

Coffee trader update

Radu's last trading day in Clissold Park is on August 2nd. It was made clear to Radu when they commenced trading that the opportunity would only be a temporary one until the cafe reopened. The Markets & Street Trading Team will be offering support to find Radu with an alternative trading site.

Capital projects

Fountains and water features

The memorial fountain has been repaired but we are monitoring this for further issues, as a new valve may be required.

Repair works

Path resurfacing has taken place in numerous places. There has been re-welding of inserts in the boundary fencing in a number of places and fences and gates have been checked.

Play area

Design work will commence in the autumn once a contractor is appointed. The play area is one of three we are looking to refurbish along with London Fields North and Millfields. The Project Manager will be in touch after the AGM with the new CPUG reps to start discussions about the play area to discuss how it could be improved.

Park Depot Update

A contractor has just been appointed to refurbish the Clissold Park Depot along with the parks' depots in Hackney Downs and London Fields.

The park depot facilities at Clissold Park are in a very poor condition and do not meet the needs of the Operations Team. The works will help to decarbonise the Parks Service, with heating and hot water provided by an air source heat pump (ASHP) and energy generated on site by solar panels. The works will also include improved purpose built secure storage and electric vehicle charge points. The single storey building is approximately the same size as the existing building and will be very similar in character to the Millfields Park Depot which was refurbished a couple of years ago. Timing and duration of the works needs to be discussed with the contractor.

Memorials

A number of memorial benches and trees have been installed in recent months.

On-going maintenance and planting

Summer months as usual, we have extra Euro bins and keepers during the summer months to cope better with the influx of park users and the litter which accumulates.

Dead hedge creation in the woodland area near the ponds to improve soil, protect tree roots and improve understorey plants. Encouraging speedwell and other food sources for *Andrena labiata*. Creation of sandy micro-habitats and logs for solitary bees

Work Update

Planting of aquatic plants. New hedgerow along Green Lanes is taking well and this will be expanded in Autumn.

Crime and anti-social behaviour

Banners

New banners have been placed around the park to encourage good behaviours/ use of the Park over the summer months

Bench under house canopy

The bench under the house canopy was heavily damaged by vandalism and is likely beyond repair, however we are getting quotes to get a full picture on this.

Fire warning

We are in the middle of an extremely dry period and the park is very vulnerable to fires. Please call the fire brigade if any fires are spotted in the Park. Emergency contact numbers and useful numbers are displayed in the

park's display boards. General enquiries can also be made to the Council's call centre on 0208 356 3000 Monday to Friday 9am-5pm.

Animals

Some structure repairs have taken place to the deer enclosure and aviary.

Other

Staffing

There is currently no dedicated Manager for Clissold Park, instead the Parks Development Officer for the North, Georgie Brown, is our main point of contact but is not a dedicated resource to just Clissold Park.

Defibrillator

The Parks Team are in support of the groups wish for a defib within the Park. Discussions have been taking place internally around the possible location for this. Feedback from the Conservation Officer has meant the listed building is not a suitable location for it and the advice is to locate away from the building totally or in the building basement which is not practical. Following further discussions, we are proposing a location of the Tennis Pavilion and Hackney Tennis have kindly agreed to this suggestion. We can install information on the location of the defib in noticeboards around the Park, so to ensure everyone knows where it can be found. There is also a person in attendance at the Pavillion, so this again helps with the risks of vandalism and disturbance. I hope this is good news for the group and I look forward to discussing further in due course.

Chair's Report

Café

Group heard statement from Mat and Jess and Fink's regarding the opening of the Rose Garden kiosk soon.

Action: Margaret to arrange meeting with Fink's to discuss menu and pass on user concerns re pricing.

Cycling Day of Action/Speed Roundels

Event application sent to Hackney council and Dr Bike contacted. Officers to discuss costs once we have a quote. Safety leaflet to be designed once dates are confirmed. Attendees discussed safety concerns over e-bike use in Hackney parks, and bylaws being outdated and expressed a desire to have these looked at, as well as restrictions or an outright ban of electric vehicles in Hackney parks. Group heard that speed roundels were painted at busiest entrances only, taking cost into consideration.

Action: Fliss to contact police to arrange bike marking session, to run concurrently with cycle repair and awareness day. Alexandra to liaise with Cycling Rep Richard on leaflets and hosting the event.

Biodiversity

Last bat walk was a successful event. Eco volunteering sign-up sheet circulated. 28 breeding species of birds were spotted during the last survey, with 2 of the usual breeding species not being spotted.

Action: Richard to contact eco volunteers and arrange sessions.

Self-Closing Gates

Brought up in meeting with Bruce Irvine regarding the design for the new playground. Bruce to raise delay and need for self-closing gates in other areas in the park, with park management.

Action: Alexandra to liaise with Bruce.

Park Animals

Quinten has advised Animal Reps Sally and Chris to contact Hackney Park Rep Georgie Brown, to discuss future of the goat enclosure. Sally doing some research on suitable goat breeds, should park management decide to home some at the park. One of the lake fountains and an aerator is up and running, with the others waiting for parts. Dead fish in pond flagged with park management.

Action: Sally and Chris to connect with Georgie Brown. Alexandra to follow lake fountain repair works.

Use of Clissold House for CPUG fundraising/CPUG Quiz Night

Quiz Night booked for 11th September 7pm, tickets to go on sale and call for volunteers to help at the quiz, to go out soon. Group to fund security for events at £180 including VAT. Chair extended thanks to Hilde and Yvonne for their perseverance in securing free use of Clissold House for 2 CPUG events per year.

Action: Alexandra to design and send out poster advertising event

Defib

The Hackney Parks Team are in support of the groups wish for a defib within the park. Discussions have been taking place internally around the possible location for this and the council are proposing a location of the Tennis Pavilion, which Hackney Tennis have kindly agreed to. Information on the location of the defib will be available on noticeboards around the park.

Playground Renovations

Group pleased to hear the council has met with chair and Disabilities and Accessibilities Rep Ruth, to discuss the new playground design, share ideas and put across the need for accessible equipment. Public awaiting consultation on the space, and Alexandra will share this with the group once it is made live. No further action needed.

One o'clock Club

Advertising improved. Alexandra mentioned club information being difficult to find online in discussions with Hackney Parks Rep Georgie Brown, who is going to look into it.

Action: Alexandra to liaise with Georgie Brown.

Rose Garden

Broken and sharp edges on fencing a safety hazard. Yvonne Hill suggested low wicker fencing.

Action: Alexandra to raise safety and design concerns with park management.

Rats

Alexandra mentioned the current number of signs on the ponds being up to 4, and expressed a desire to get all of the information on those signs correlated into one, including information on water fowl feeding that does not encourage rats. Richard Crawford asked if an alternative to zip ties could be used. Cyndi Diamond asked if signs could be produced in eye-catching colours.

Action: Alexandra to enquire about signs.

Ducklings and Ponds

Ramps installed. No further action is required.

Chicken coop

No plans for the chicken coop at the moment. Georgie is keen on group suggestion of a outdoor classroom or similar, and would like to revisit the subject at a later date. No further action required.

Water leak near Keepers Lodge

Water tested by Thames water and found not to be drinking water caused by a leak, but where water pools in bad

weather due to the incline of the park. No further action needed.

Prohibited action signs

Signs have been erected in Alexandra has raised issues with posters tearing to Hackney Park Rep Georgie Brown, who had already contacted the manufacturer regarding this.

Action: Georgie to feedback to Alexandra once manufacturer has made contact.

Maps

Caroline Millar expressed a desire to get a new version the maps designed as soon as possible.

Action: Alexandra to liaise with History Rep Amir and artist Anna Hymas.

AOB

Park keepers house

Margaret Renn informed the group that the occupant had passed away, and that an email had been sent to the council to make enquiries as to whom the house is owned by, and how it will be used, now that it is unoccupied.

Action: Margaret to report back to group.
